

**ORD-16-008**

AN ORDINANCE TO AUTHORIZE THE MAYOR OF THE CITY OF CANAL WINCHESTER TO MAKE APPLICATION TO THE STATE OF OHIO IN ACCORDANCE WITH THE OHIO REVISED CODE SECTION 4301.80 TO ESTABLISH A COMMUNITY ENTERTAINMENT DISTRICT WITHIN THE CITY OF CANAL WINCHESTER, OHIO KNOWN AS THE DILEY ROAD COMMUNITY ENTERTAINMENT DISTRICT.

**WHEREAS**, the City of Canal Winchester desires to establish a Diley Road district bound by the areas generally on the east side of Diley Road from US 33 to the intersection of Busey Road and specifically shown in the map attached hereto as Exhibit A and made part hereof; and

**WHEREAS**, Ohio Revised Code Section 4301.80 provides the guidelines for the City of Canal Winchester to establish a Community Entertainment District; and

**WHEREAS**, the creation of a Community Entertainment District with the City of Canal Winchester in the Diley Road area will provide the city with another tool for economic development, and business revitalization; and

**WHEREAS**, the Diley Road Community Entertainment District contains no less than 20 acres in accordance with 4301.80;

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CANAL WINCHESTER, OHIO:**

**Section 1.** That the Council of the City of Canal Winchester finds and determines that it is in the best interest of the city to establish a Community Entertainment District to be called the Diley Road Community Entertainment District to improve and provide entertainment, retail, education, sporting, cultural, and arts opportunities for the City of Canal Winchester.


**Section 2.** That this Council hereby authorizes the Mayor to file an application and all necessary paperwork to establish the Community Entertainment District pursuant to Section 4301.80 of the Ohio Revised Code and to file all necessary paperwork for the area comprising the Community Entertainment District as is more fully described in "Exhibit A and Exhibit B", consisting of a parcel map and a list of parcel numbers, attached to this ordinance and incorporated herein.


**Section 3.** That the Council of the City of Canal Winchester hereby establishes the boundaries of the Diley Road Community Entertainment District as attached hereto and incorporated herein as "Exhibit A".

**Section 3.** That this ordinance shall take effect and be in force from and after the earliest period allowed by law.

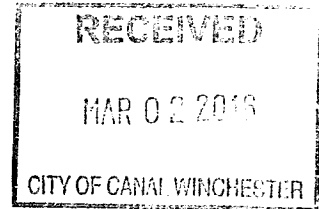

Although not a legal description, the boundaries of the proposed CED are generally depicted in Exhibit A and all parcels within the proposed CED are listed by parcel identification number on Exhibit B, attached hereto.

**3. A general statement of the nature and types of establishments described in Ohio Revised Code Section 4301.80 (A) that are or will be located within the CED and any other establishments not described:**


(A) As used in this section "community entertainment district" means a bounded area that includes or will include a combination of entertainment, retail, educational, sporting, social, cultural, or arts establishments within close proximity to some or all of the following types of establishments with the district, or other types of establishments similar to these:

1. Hotels;
2. Restaurants;
3. Retail sales establishments;
4. Enclosed shopping centers;
5. Museums;
6. Performing arts theaters;
7. Motion picture theaters;
8. Night clubs;
9. Convention facilities;
10. Sports facilities;
11. Entertainment facilities or complexes;
12. Any combination of establishments described in division (A)(1) to (11) of this section that provide similar services to the community.

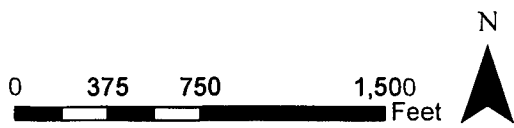
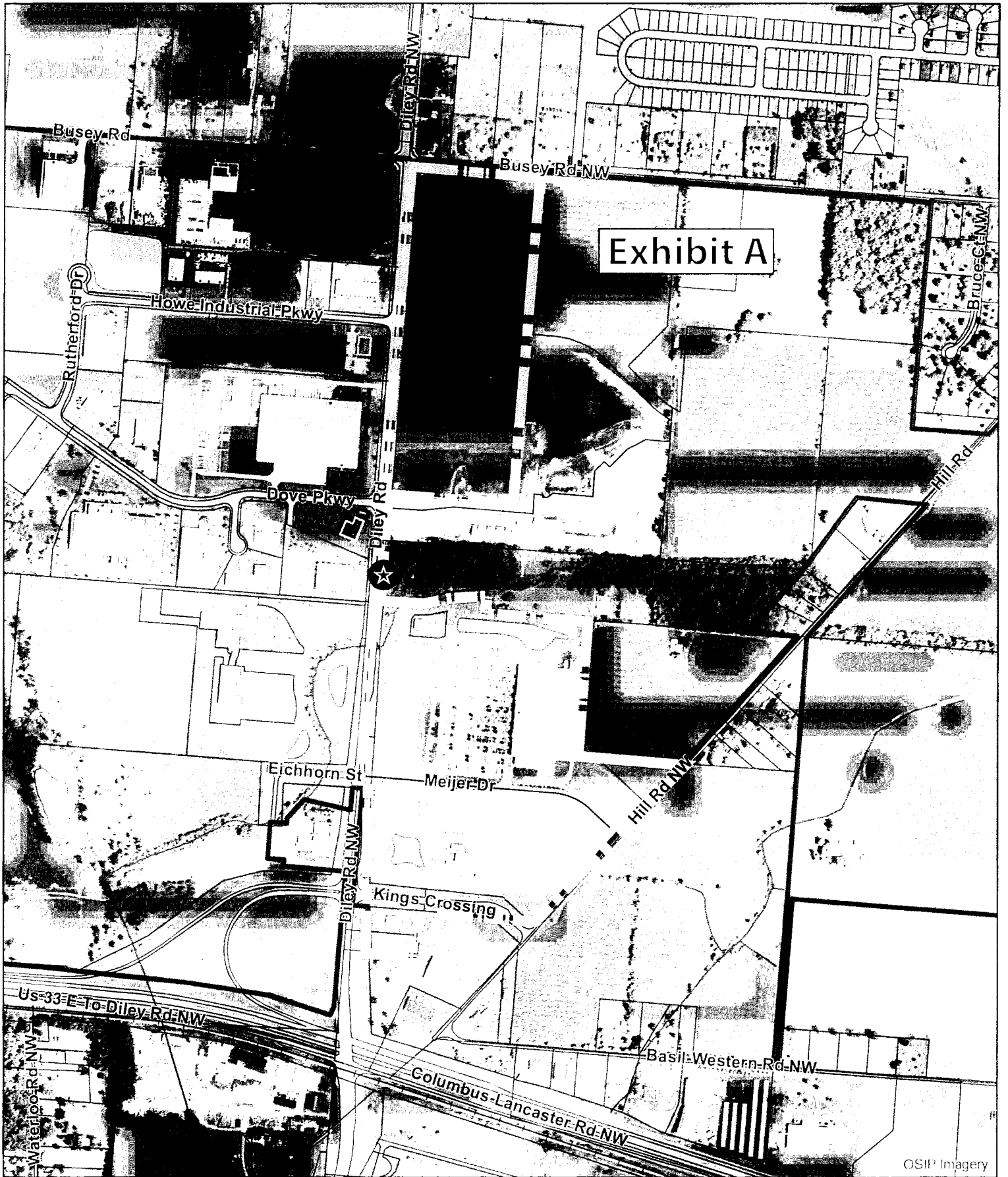
7. A handling and processing fee to accompany the application , payable to applicable municipal corporation or township, in an amount determined by that municipal corporation or township:

District

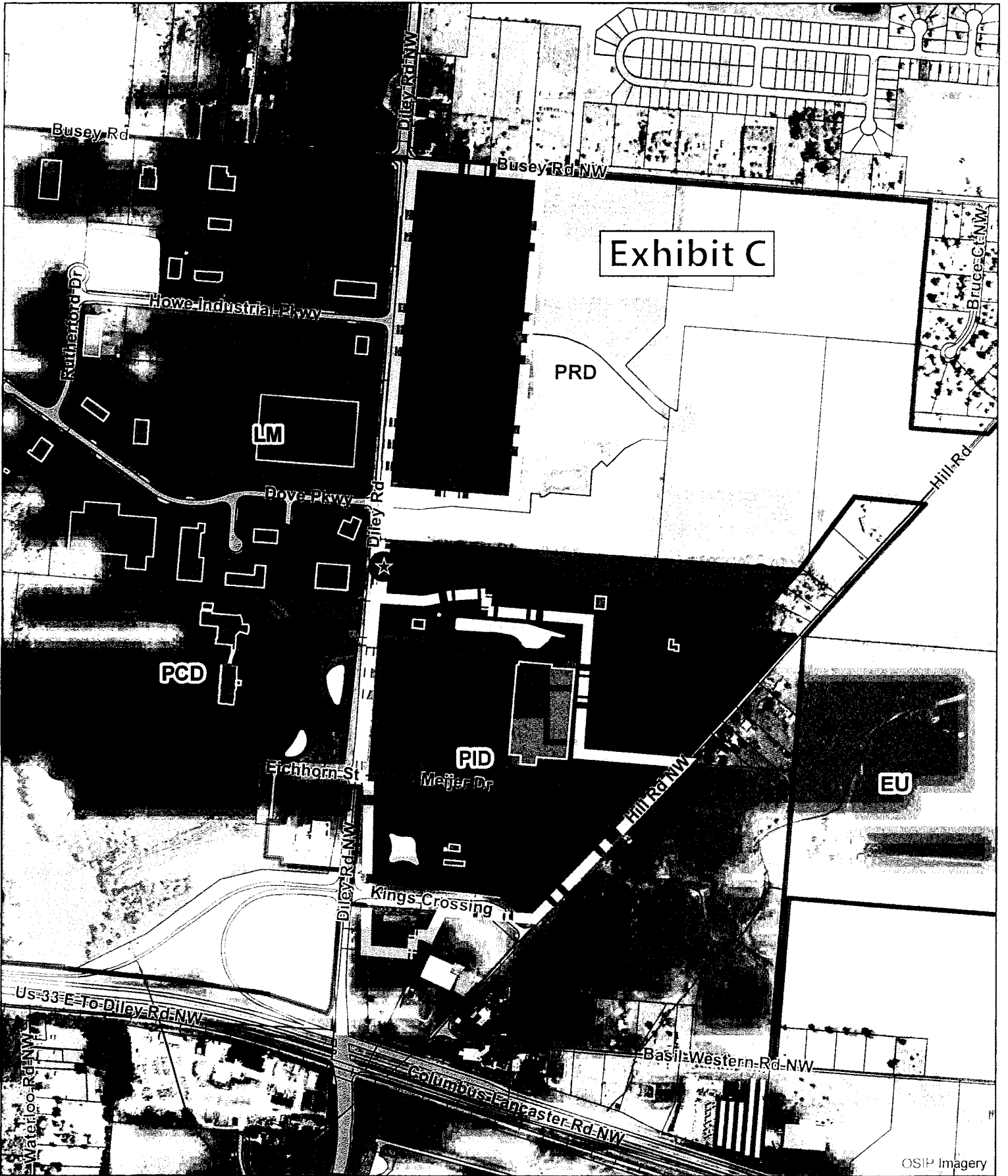

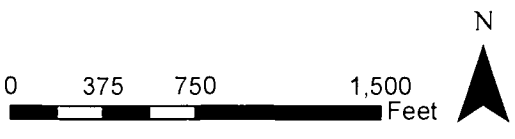
